State Authorization & Professional Licensing

The State Authorization Reciprocity Agreement, or SARA, does not deal with professional licensing board approval for programs leading to state licensing in the fields of Cosmetology, EDT, etc. A state's laws may require practitioners to be licensed to practice in that state.
